#### What about Wetlands?

Almost all land in Nassau County is within 1/2 mile of a wetland, whether stream, marsh, river, or pond. Wetlands provide protection against flooding, filter pollutants, nurture and support our wildlife, recharge groundwater, and provide opportunities for recreation and fishing. Since 1972 the Clean Water Act has provided guidance for protecting our wetlands from pollutants and dredging or filling. Over the years, part of the battle in protecting our wetlands has revolved around defining what a wetland is. Are wetlands only navigable waters like rivers and lakes or do isolated but adjacent marshes, ponds, and other wetlands count? A recent U.S. Supreme Court ruling, Sackett v. EPA, overturned 45 years of policy based on science and changed the definition of a wetland to only include navigable waters and adjoining wetlands. This leaves the determination of protected wetlands up to the states when considering pollutants, dredging or filling. Although agreeing with the ruling, Justice Kavanaugh wrote ".... there is a good reason why Congress covered not only adjoining wetlands but also adjacent wetlands. Because of the movement of water between adjacent wetlands and other waters, pollutants in wetlands often end up in adjacent rivers, lakes, and other waters. Natural barriers such as berms and dunes do not block all water flow and are in fact evidence of a regular connection between a water and a wetland."

It is now up to the state of Florida to regulate many of our wetlands.



## **Catch Up With Your Community**

Members of Conserve Nassau were at the city's Vulnerability Assessment Workshop on Monday Sept. 18 and provided feedback to city staff and consultants on areas of concern for flooding.

Kelly Gibson, Planning and Conservation Director for Fernandina Beach provided the following statement. "The City hosted the first of two Resiliency Outreach event on Monday, September 18, 2023. This event sought information from the community to identify flooding vulnerabilities throughout the City. A second community meeting to share data will be held in November. These outreach opportunities are part of the City's Resilient Florida Grant to establish a City-wide Vulnerability Assessment consistent with Florida Statute 380.093. Completion of these efforts will allow the City to obtain future grant dollars to support infrastructure investments. We look forward to seeing you at future events! "
